#### TREASURER'S REPORT

It has been an active year so far for the Treasurer /Finance Committee function. We have continued the efforts of the previous Treasurer in the continued enhancement of the Treasurer's Report to provide additional information. Summary information is now included in the published Board Minutes in the Members Only section of the BCLCA website to provide information to the Members on the financial performance of BCLCA. The Capital Reserves continue to grow as planned in the Reserve Study conducted in 2015. Below is a schedule of capital improvements completed so far in the current year; the total is just slightly over \$24,000.

As the Capital Reserves continue to grow, we have begun the investigation of engaging an Investment Advisor to provide guidance in the investment of the reserves. An initial Investment Policy Statement governing the type of investments and the allocation among investment classes (i.e.- Cash, Bonds and fixed income investments, etc.) has been drafted and is under review by the Board. The Finance Committee has also been working on an Accounts Payable policy that will document the vendor invoicing process as well as verifying insurance coverage by Contractors utilized by BCLCA.

There has been limited or no turnout for the "Talk with the Treasurer" sessions generally held the second Saturday of each month, at 11am. The purpose was to have an open forum to go over any questions Members may have on financial related matters of BCLCA. I plan to conduct sessions through May (with the May 13th session on the Capital Reserves). If attendance remains low, I will discontinue the Talk with the Treasurer sessions.

A new collateral bond for the dam required by the state was issued at the end of December, backed by a Letter of Credit issued by Mauch Chunk Trust Company. This resulted in a savings of over \$4,200 in insurance expense from the prior year.

#### **Human Resources**

During March, I worked with Colleen Bradley in reviewing and updating the HR forms and New Hire forms required by the Lifeguards in preparation for the extensive hiring process Colleen goes through to staff the Pool for the summer. I have started looking at the Human Resources policies for revamping, as they have not been significantly updated for several years.

#### **Special Projects Committee**

By the time you receive and read this, you will know the key project of the Special Projects Committee has been a rewrite of the Bylaws, which has been many years in the making. Much information has been published on the Members Only section of the website, and three Town Hall sessions will have been held in April to communicate the reasons for the update and the changes. The members of the Committee (including Margo Schaefer, Jack McGeehan, Bill Alison, Jay Blumenthal) have collectively spent over 200 hours in this effort, and should be thanked by all. I hope that the Members will support this initiative at the May General meeting.

The Special Projects Committee has also been looking at the background checks requirements as result of state regulations. We will be working with the BCLCA's Solicitor over the next couple of months to develop sound and comprehensive policies and practices.

#### FROM THE EDITOR

Last August, we conducted a survey of our Members regarding communications, and we received 214 replies electronically and a handful of written replies. Some of the findings:

- The respondents were evenly split between full-time and weekenders
- The newsletter is widely read (178 said they read it all)
- Most of the respondents use the BCLCA website on a regular basis (162 regularly or occasionally)
- A majority had signed up for Members Only access to the website (169 respondents)
- There is some interest in receiving the newsletter in digital form only (68 said they would)
- The bulletin boards are checked regularly by a majority of respondents (155 regularly or occasionally)

Our survey was not scientifically designed but gave us the first snapshot of the effectiveness of communications to our Members. Things change very quickly: use of the Members Only section of the website has increased dramatically since our initial survey.

As usual, this issue contains many items about activities that are planned for the summer (including a calendar listing the events). #### **RULES**

The big news is the proposed new Bylaws, which should be in Members' hands before this newsletter arrives. In order of precedence, the individual deeds come first, followed by the Bylaws and the Rules. Some features of the Rulebook will now be incorporated in the Bylaws (such as the citation appeals process) and we will follow up with a description in the late summer edition of the newsletter.

There were several changes that were approved by the Board since last year's General Meeting:

- After a successful trial, the permission to launch paddle-powered craft from the right sides of the beaches has now been made permanent.
   Please observe the signs and respect the property of the Members adjacent to the beaches (please stay off their property!).
- In order to obtain approval for any building project, the Member must provide BCLCA with copies of all permits required by other entities, such as Penn Forest Township and the Department of Environmental Protection.
- The fine for speeding (up to 14 MPH over the limit) has been reduced to \$50 plus \$5 costs, for the first offense.

docks on the lake should have a GP-2/3 in their records and those who have such permits should send a copy to the office. I will start looking at properties, to make sure they are in compliance with state waterways laws.

Meanwhile we're continuing the financial planning that started in 2015, to make sure that we maintain our roads, dam, pool, Stewart Hall, and existing beaches. In the future, we'd like to find a safer way for people to walk, bike, or drive golf carts around the lake, and possibly find a way to launch small boats from the west

side of the lake as they do now from the south, east, and north sides.



We are happy to report that the lake has returned to normal levels after a year of lower than average precipitation. Water was flowing over the spillway even before the blizzard in March. Our lake continues to offer us exceptional water quality for fishing and recreational use and we hope everyone will continue to be diligent in keeping it that way. This includes not using pesticides/herbicides and cleaning up after your pets.

This past fall, 1000 Black Crappie and 5000 Golden Shiners were stocked in the lake per the recommendations of the recently

completed Fish Survey. The goal is to have a balanced fish population, which, as recommended, is 4 pounds of forage fish per every pound of predator. One goal is to have a desirable amount of Sunfish and Golden Shiners, which are favored by the Bass. Several other recommendations from the survey included: Additional stocking suggestions and to limit harvesting of any Largemouth Bass under 20 inches and Sunfish under 7 inches. Limiting the harvest of Sunfish to those larger than 7 inches will help establish the breeding population of Golden Shiners. For the full report of the 2016 Fish Survey, go to the BCL Members Only Web page.

Reminders: both beaches have designated areas that can be used to launch paddle craft.

- Trailer stickers are required and this will be enforced starting this year.
- No live bait other than what is listed in the rules may be used in the lake for fishing. NO MINNOWS, PLEASE!

# **ENVIRONMENTAL COMMITTEE**Ken Levitz

In July 2016, I wrote a three-paragraph commentary for our Newsletter in anticipation of our Fall General Membership Meeting. In the first, I acknowledged the passion and commitment shown by various members concerning issues that originated in the broader community of Penn Forest Township. At that time we had recently witnessed the completion of a Game Commission maintenance facility adjacent to our boundary and the ongoing township zoning board issues concerning the proposed Atlantic Wind Farm construction. The township and adjacent municipalities are now, also engaged in various proposed pipeline controversies.

The second and third paragraphs dealt with ongoing pest infestation issues: namely gypsy moths and mosquitos. To many the three topics may seem vastly different in scope and in level of concern. To me, they provide a "point/counterpoint" concept.

The type of issues described in the first paragraph can involve external municipalities, states and organizations and usually revolve around significant infrastructure projects. While we as individuals (and as included communities) can always inject our positions into ongoing debates, we seldom cast the final

deciding vote.

Pest issues such as those listed above will probably be with us – at varying degrees for quite some time. The difference between the two types of problems is the amount of control we as a community and as individual members have in reducing and hopefully eliminating their impact on our community and our individual life styles.

Gypsy Moths and mosquitos will still be a concern this warm season, but we are continually researching control methods that are financially feasible and economically sound. Please see the website for the latest results. The added value to these ideas is that we can implement them as individuals on a small scale that will lessen the negative impact of these pests.

Storm water – sometimes offsite run-on - and at times internally compounded by our desire to pave more surface than is good for the health of the lake. While we continue to monitor offsite construction and will contact the township and the conservation district when appropriate, we can also help ourselves by recognizing the value of a permeable stone driveway in terms of lake protection. We can also lessen any negative impact by carefully choosing the herbicides and turf builders we use.

Now is the time for my usual preaching: another low cost, lake (and well water) health protection practice is – ready for this! – to clean up after our pets. Not only can we protect our own health, and that of our children and grandchildren, we can extend the courtesy of a cleaner walkway to our neighbors.

Finally, BCLCA, as a municipality, recognizes that the association also has an obligation to avoid impacting our members as well as adjacent properties with an activity, or a failure to provide adequate environmental protections in the conduct of our regular management

duties. To that end, the Board continues to review its physical plant and maintenance procedures – and seek advice to assess any potential financial liabilities. Our most recent effort led to the replacement of all fuel oil and chemical tanks in service at the maintenance garage, Stewart Hall and the pool with secondary spill containment vessels. See additional comments and cost information in the President's letter and in the Treasurer/ Financial Committee Report. By the time this is in print we will have updated our review and consulted with insurance professionals to determine if there are any gaps in our coverage.




